<u>NOTE</u>: Vacancies may be increased or decreased at the time of selection/counselling. The number of vacancies, indicated as above, is provisional and subject to change without any notice.

2. 11 posts of Junior Resident are horizontally reserved for Persons with Benchmark Disability (PwBD) as per DOPT, Govt. of India Rules issued from time to time.

3. Eligibility Criteria: -

Duration of Residency: - One year w.e.f. 01.07.2025 to 30.06.2026 in two subjects for six Months each.

Pay Scale : Rs. 56100/- in Pay Level-10 in the Pay Matrix as per 7th CPC + NPA and Other allowances as admissible as per Govt. of India Rules.

Qualification: -

MBBS Degree from a Recognized University & must be registered with Delhi Medical Council (DMC).

- Candidates must have completed their Internship on or after 01.07.2023.
- FMGE Certificate for FMG candidates.
- DMC Registration is mandatory. (Receipt will be considered but original DMC Registration required before the joining, if selected).

Mode of Selection:

i) A Screening Test, comprising a written examination of one hour duration based on multiple-choice questions (MCQs), will be conducted. This will be succeeded by a counselling session, wherein candidates will be allocated seats

in various departments according to their merit scores attained in the written examination.

ii) Candidates three times the number of vacancies (or less if not available) who qualify screening test will be called for counselling, as per merit list.

Application fees: General/EWS/OBC candidates - Rs.1000/- (Non-refundable)

SC/ST/PWD candidates - No fees

Conditions of Recruitment: -

1. The application should be submitted online through the website (www.vmmcsjhrecruitmentexams.ac.in)

- 2. Applicants should submit their application online, along with scanned copies of all relevant documents in support of their candidature for the post. One recent passport-size photograph and signature should also be uploaded.
- 3. The start date for the online application is 10-05-2025.
- 4. The last date for submission of the online application is 25-05-2025 till 5:00 P.M.
- 5. Tentative date of written examination is 01.06.2025 (Sunday).
- 6. Venue for written exam will be VMMC & Safdarjung Hospital, New Delhi.

- 10. (i) For OBC Candidates please attach certificate from appropriate authority, which is meant for the post under the Central Government of India, and must Certified that the Candidate does not belong to Creamy Layer. Date of issue of Certificate should be on or after 01.04.2025.
 - (ii) For SC, ST candidates certificate should be issued by Tehsildar or above rank officer in format of State Govt / Central Govt. of India.
 - (iii) For EWS candidates submit copy of Income & Asset Certificate as per given Annexure-II having date of issue on or after 01.04.2025 valid for financial year 2025-26 Candidates must ensure that he/she falls under EWS category otherwise their candidature will be rejected.
- 11. Crucial date for determination of eligibility will be the last date of submission of online application.
- 12. The tenure of Junior Resident is one year including any service rendered earlier as Junior Resident on adhoc/regular basis in any Govt. of India/State Government hospital/institution.
- 13. Other service conditions will be applicable as per service conditions prescribed from time to time by the Govt. of India.
- 14. The candidate who is already employed should submit No Objection Certificate from present employer at the time of joining.
- 15. The candidate must bring all the uploaded certificates and any other relevant documents in original for document verification at the time of joining.

- 16. No correspondence shall be entertained after the last date for receipt of application.
- 17. No TA/DA will be paid for attending the exam & interview.
- 18. No separate call letters for written examination and interview will be issued. Candidates are advised to visit official website (www.vmmc-sjh.mohfw.gov.in) at regular interval for all further notifications.
- 19. List of shortlisted candidates for counselling and final selected candidates will be displayed on the official website (www.vmmc-sjh.mohfw.gov.in).
- 20. Tentative date of joining will be 01.07.2025. However, candidates may be called 4-5 days before the tentative date of joining for document verification and medical examination.
- 21. Candidate has to submit only ONE APPLICATION. If multiple applications receives from the same candidate, his/her candidature will be summarily rejected.
- 22. Admit Card for written examination can be downloaded after log in the online registration portal (www.vmmcsjhrecruitmentexams.ac.in). Candidates must bring hard copy of admit card alongwith original identity card i.e. aadhar card/pan card/voter card/driving license/passport at the time of written examination.
